
Requirements

- 3.5 mm audio cables
- · Computer system or video card enabled with DisplayPort
- · Computer system enabled with USB
- Display device (for example, monitor, projector, TV, and so on) enabled with DisplayPort
- Standard wired or wireless USB keyboard
- Standard wired or wireless USB mouse

Installation

Set up your PC

The following setup changes are required for PC users and aren't necessary if you're using a Mac computer.

- 1. In Standard CMOS, set Halt on Error to All But Keyboard.
- 2. In PNP and PCI Setup, set PNP OS Installed to Yes.
- 3. In PNP and PCI Setup, set USB IRQ to Enabled.

Connect the console to the KVM switch

- 1. Turn o your computer and any devices or peripherals that are connected to it (for example, printers, external hard drives, and so on).
- 2. Connect a monitor or display to the console DisplayPort port.
- 3. Do one of the following:
 - Connect a keyboard and a mouse to the USB keyboard and mouse ports.
 - If you're using a combination wireless keyboard and mouse, connect the wireless receiver to the keyboard port.
- 4. If necessary, do any of the following:
 - Connect speakers to the console audio speaker port.
 - Connect a microphone to the console mic port.
 - Connect USB peripherals to the USB hub ports.

Connect a computer to the KVM switch

Notes:

- This KVM switch uses generic HID drivers, meaning no software or driver installation is required.
- You can connect up to four computers to the KVM switch.
- The cables for each individual computer must be connected to the same port set on the KVM switch.
- 1. Turn o the computers that you want to connect to the KVM switch and any devices or peripherals that are connected to the computers (for example, printers, external hard drives, and so on).
- Connect a DisplayPort video cable to the DisplayPort ports on your computer and to one of the PC DisplayPort ports on the KVM switch.
- 3. Connect a USB cable to the USB port on the computer and to the PC USB port on the KVM switch.
- 4. If you're using audio, connect speakers to the console audio out port and your microphone to the console audio in port on the KVM switch.
- 5. To connect additional computers, repeat steps 1 to 4.
- 6. If you want to share USB peripherals between connected computers or devices, connect the peripherals to the USB hub ports on the KVM switch.
- 7. Connect the universal power adapter to a power source and to the power adapter port on the KVM switch. The Power LED illuminates to con rm the switch is receiving power.
- 8. Turn on any devices or peripherals that are connected to the KVM switch, and then turn on the connected computer. Wait for the computer to nish loading and then test the functionality of the keyboard and mouse of the connected computer.
- 9. If additional computers are connected to the KVM switch, select a di erent port and repeat step 8 until you have tested the functionality of all of the connected computers.

Auto scan

The KVM switch features Auto scan which enables you to automatically switch between the connected computers at a timed interval.

To activate Auto scan, hold down Port selection buttons 3 and 4 simultaneously, until the KVM switch beeps. You can repeat this process multiple times to change the timed interval between 3, 8, 15 and 30 seconds respectively.

To exit Auto scan, press any of the port selection buttons.

About the LED indicators

The KVM switch comes with a port selection/link LED for each port, as well as a power LED. For more information about the LEDs, consult the table below.

LED	Behavior	Scenario
Power LED	Illuminated	KVM switch is receiving power
Port LEDs	Illuminated green	Connected computer is turned on
	Illuminated red	Connected computer is currently selected
	Blinking	Auto Scan process is in progress
